INSTRUCTIONS FOR AUTHORS

The editorial board accepts unpublished papers in Croatian and English. Papers should be submitted in electronic form. The editorial board reserves the right to adjust the papers according to the propositions of the journal and standards of the Croatian or English language. The papers will be reviewed by scientists and experts of the specific area who will determine the categorization of papers and decide whether the paper is acceptable to be published. The paper will be published in the Proceedings, after positive review.

The editorial board reserves the right to reject the paper.

Paper format:

- 1. The first page should contain: the paper title (in Croatian and English), author's name, name and address of the institution where the author is employed and email address of the author. It is followed by an abstract containing a brief overview of the paper, purpose of the paper, description of research methods, results and conclusion. The paper should be written in passive voice.
 - The abstract should contain between 100 and 250 words, with the key words (3-6 words) below, which are important for indexing and classification of the paper. The abstract and keywords are written both in Croatian and English.
- 2. Paper length (including bibliography, graphs and tables) should be limited to one type-written double-spaced page (12000 characters). In special cases, publication of the papers which exceed the specified number of characters shall be approved, upon the decision of the editorial board.

3. TECHNICAL DETAILS OF PAPERS

Authors should format their papers as follows:

- Format: A4Margins: 3 cm
- Font Times New Roman
- Font size:
 - font **14** title
 - font **12** content and chapter titles
 - font **10** footnotes
- Spacing:
 - 1,5 for main part of the text
 - 1 for notes, i.e. FOOTNOTES
- Alignment Justified

- Paragraph indentation 0,5 cm
- Paper should be written in PASSIVE VOICE!
- Foreign words should be written in italics or in brackets. For example (English *Software*), (German *Netzwerk*)
- 4. Illustrations (tables, pictures, drawings, diagrams) should be prepared for black-and-white print (please avoid shading, etc. since these effects reduce visibility). Size and complexity of graphic material should be adapted to the journal's format (A4) in order to clearly see all elements. Captions should be written above the illustrations and the sources from which they were taken under them.
- 5. It is not necessary to number the pages. Chapter and subchapter titles should be numbered. Authors are recommended to use the same font for chapters and subchapters, as well as for the rest of the paper and should not indent the titles, since the text will be graphically edited. Chapters should be written one after another, so is it is not necessary to break pages.
- 6. Authors are advised, for the purposes of efficiency and easy reference, to cite the sources (references to other texts, citing papers) as follows: the source should be mentioned in the text, not in footnotes. Reference is given in parentheses and contains the author's last name, publication year and, if it is a quote, page number, for example: (Goodstein, 2003) or (Goodstein, 2003, 93). If there are two authors, both should be noted, for example: (Panian and Strugar, 2000) or (Panian and Strugar, 2000, 76). If there are three or more authors "et al." should be used, for example: (Sikavica et al, 2008). All references in the text are listed, and forms such as "ibid", "op cit." and similar should not be used. The authors are advised to use the notes exclusively for commenting or supplementing the text.
- 7. The list of references (bibliography), listed at the end of the paper, should provide full details of all papers mentioned in the references. The papers are listed alphabetically by authors and chronologically for the papers of the same author. More works of one author, which are published in the same year should be differentiated by letters (a, b, c) after the publication year.

- 7. Publication place
- 8. Publisher
- 9. Number of pages
